2. There will be no smoking inside any of the buildings.
3. All cartridge firearms will have their actions secured w/plastic ties to prevent their operation except those attached to a " NOT FOR SALE" display and a part thereof.
4. No loaded firearms are permitted in the show @ any time except by armed guards and law enforcement officers.
5. The Show producer reserves the right to refuse space to anyone when in the Show producer's opinion the use of the table(s) is not in the best interest of the show. Militant and/or indecent material the show chairman believes to be offensive to the general public WILL NOT BE PERMITTED. This includes (but is not limited to) books, video/audio tapes, T-shirts, and bumper stickers that contain pornography, obscene language or graphics, or racial, ethnic, sexist, or hate-mongering material. If you have questions regarding the suitability of your merchandise please call.
6. No books or film media may be offered for sale that describe the fabrication of any device which, if possessed, would constitute a felony under the laws of the United States.
